

# Dialogue on Fairness

# A Series of Science for Policy Events

Europeans are better educated and live longer, healthier and more prosperous lives today than a few decades ago. However, not everyone has experienced similar improvements. Income and wealth inequalities have risen and social mobility is still limited. This may be fuelling the discontent felt by many of our fellow citizens. Recent data show that 39% of Europeans believe that they are not treated fairly and 42% do not agree that they have equal opportunities in life.

Starting autumn 2019, the Fairness Community of Practice (CoP) will organize a series of events to foster and deepen the dialogue between policymakers and academic researchers on increasingly relevant topics related to fairness: measuring absolute poverty in the European Union; how families' socio-economic circumstances shape their children's school achievements; and how insights from behavioural sciences can help us understand perceptions of fairness.

These events, held in Brussels, will precede the launch of the second JRC Fairness Report. The report will contribute to a better understanding of income inequality, inequality of opportunities, (un)fairness perceptions and what policy makers can do about these issues.

## 30 SEPTEMBER 2019. Towards an Absolute Measure of Poverty in the EU

Workshop

This workshop will explore the latest developments in the measurement and monitoring of absolute poverty in the European Union. Drawing on expertise from policy makers, academics and stakeholders, it will discuss the methodological challenges and possible solutions in estimating poverty.
