17 January

<u>Peer eXchange and Learning workshop on innovation strategies for smart specialisation</u>

The S3 Platform organised a Peer eXchange and Learning workshop on Policy Instruments for innovation strategies for smart specialisation (RIS3). Emilia-Romagna (Italy), Northern Netherlands (Holland) and Wielkopolska (Poland) regions provided a short account of their experience in designing and implementing policy instruments for the implementation of their respective RIS3. The event gathered representatives from more than 50 regional and national authorities.

23 January

New JRC MOOC on monitoring Smart Specialisation strategies: Presentation at the Committee of Regions

Which are the principles underpinning RIS3 and RIS3 monitoring? What are the core-indicators to monitor the sound implementation of research and innovation Smart Specialisation strategies (RIS3)? Where to find the key data-sources needed to monitor them? These are the insights which were gained from the MOOC, produced by the JRC on monitoring Smart Specialisation strategies. Dr Elisabetta Marinelli, from the JRC (Targeted Support for RIS3), presented its contents and explained how and when to register for the online course that will open in March, at a lunch-time briefing hosted by the Committee of Regions. The MOOC is open to anyone interested in monitoring knowledge-based regional development, and in particular Smart Specialisation Strategies. Specific audiences are: Civil servants working on regional development at the regional, national and European level, students or researchers interested in regional development, or research and innovation policies, consultants in regional development or research and innovation policy.

24-26 January

<u>Macro-Regional Innovation Week-Knowledge and Technology Transfer in</u> <u>Macro-Regions</u>

The 2018 edition of the Macro-Regional Innovation Week took place in Ispra (IT) from 24 to 26 January 2018, with the focus on Science and Technology knowledge for policy support and on collaboration with the JRC. The Macro-Regional Innovation Week promoted the opening of the JRC's research infrastructures and laboratories and showcased JRC's technical and scientific competences, in particular in the field of environment, energy, transport and biotechnologies. The event was an occasion to present key results of JRC's Scientific Support activities to the European Union Strategy for the Danube Region (EUSDR) that may be relevant to other macro-regions. During the three-day event, participants also received the opportunity to visit the main site of the JRC in Ispra.

25 January

First European Education Summit: learn about SELFIE and visit JRC stand

The first European Education Summit gathered EU Education Ministers, global speakers, education practitioners & business leaders together to discuss, explore and pledge for a better future for education in Europe. The event was web-streamed through the Education Summit website. The Joint Research Centre presented its digital learning project for schools, SELFIE, during a panel session in the afternoon. As the European Commission's science and knowledge service, the Joint Research Centre has been providing evidence-based policy support in the area of education, learning and skills since 2005 on many aspects including innovative, inclusive and relevant education and the rise of new (digital) skills and competences needed for employment, personal development and social inclusion.

25 January

S3PEnergy- High Level Event

The Smart Specialisation Platform on Energy have organised a High Level Event to showcase the results achieved so far and to discuss on the most effective ways to keep assisting regions specialised in the energy domain. Particular focus was given to the interregional cooperation dynamics in the domains of bioenergy, smart grids, sustainable buildings, marine renewables and solar.

25 January

Workshop: Fiscal Policy and Microsimulation

The JRC co-organised the workshop Fiscal Policy and Microsimulation that took place in Valencia (Spain). The workshop combined relevant keynote speakers with contributed papers and ran in parallel to the 25th Meeting on Public Economics, a 2-day general-purpose conference focused on Public Economics. The aim of the workshop was to provide an opportunity to bring together relevant research work in the field of fiscal policy evaluation, both from the micro and macro traditions.

29 January

JRC Science Lecture: Meeting the new challenges for the EU: until 2030 and beyond

This lunchtime science lecture was held at the CDMA Atrium by Ian Goldin the Oxford University Professor of Globalisation and Development and Director of the Oxford Martin Programme on Technological and Economic Change. It was an opportunity to share about his latest books including, 'Age of Discovery: Navigating the Storms of Our Second Renaissance', published by Bloomsbury and 'The Butterfly Defect: Globalisation and Systemic Risk', published by Princeton University Press. Ian Goldin identified the drivers of global growth, showing why emerging markets are likely to continue to grow at high levels for the coming decades. Rising life expectancy and declining fertility in Europe and elsewhere has dramatic consequences for pensions, retirement, dependency and employment patterns. Meanwhile, advances in artificial intelligence and robotics are transforming the nature of work. Technological change in other areas is leading to dramatic changes in business and consumption.
