4-5 June

FTA2018 - Future in the making

Today's policymaking environment is complex. People seem to lose trust in policymakers and democracy. This is already leading to profound transformation. The number and variety of actors increased. There are new channels of involvement and influence. Policymakers are confronted with an accelerating speed of change. The emergence of novelty requires not only rapid reaction but also creation of new meaning and sense. The conference contributed to transformation and innovation in policymaking by:

- · Presenting and debating insights from recent future-oriented work on specific policy relevant topics
- Sharing experiences of how foresight has been used in policymaking
- Demonstrating how foresight has influenced policy processes and decisions
- Supporting the advancement of methods, practices and complementary approaches to changing policymaking needs
- Stimulating the uptake of these approaches and exchange between practitioners and policymakers

5 June

<u>Conference on Higher Education and Smart Specialisation: Partnerships for</u> Regional Transformation

The objective of the conference was to show how regional partnerships involving universities and other higher education institutions (HEIs) can drive Smart Specialisation Strategies. It brought together the outcomes of two related projects: Higher Education for Smart Specialisation (HESS), managed by the European Commission's Joint Research Centre in cooperation with DG Education and Culture, and Thinking Smart, an Erasmus+ funded consortium of European HEIs. An overall vision of the European policy context was provided by representatives from DG JRC, DG REGIO and DG EAC, together with the presentation of the JRC handbook that illustrates how national and regional authorities can form strategic, mutually beneficial partnerships with HEIs. The conference gave the opportunity to discuss about different HEIs capacities, specific contributions they can make to the design and implementation of S3, incentives that could be put in place and learn from examples from across Europe to inspire and exchange experiences. The event brought together three European Commission Directorate Generals, national/regional public authorities managing S3, higher education institutions, EU networks representing regions and development agencies, EU university associations and other stakeholders interested in promoting university collaborations for regional growth.

6 June

EU Sustainable Energy Week (EUSEW)- Energy storytelling: why stories matter to scientists and policy-makers in energy policy

In the context of the EUSEW 2018 Policy Conference, the European Commission's Joint Research Centre organised the workshop "Energy storytelling: why stories matter to scientists and policy-makers in energy policy". The workshop addressed the growing gap between scientists and EU-citizens when it comes to understanding the science behind- and the relevance of- energy, climate, and transport to our everyday lives. To have a policy impact, science needs to move from an arms-length, one-shot, fragmented delivery of knowledge towards an iterative, collaborative, holistic approach. This means new skills, and tools: visualisation, research synthesis, knowledge management and community facilitation, citizen/society/stakeholder engagement, etc. Storytelling can form a valuable tool in order to get our message across.

11-12 June

<u>2nd Symposium on Management of Future Motorway and Urban Traffic Systems</u> (MFTS2018)

The 2nd Symposium on Management of Future Motorway and Urban Traffic Systems (MFTS2018) was hosted by the Joint Research Centre (JRC) in Ispra (Italy). Representatives of policy, industry and science discussed the latest advances in the field of traffic management. MFTS2018 aimed at giving answers to:

- How to address challenges of current and future traffic management
- How connectivity and automation can support an enhanced traffic management in the future
- Options for a future enhanced traffic management: centralised vs. decentralised

11-15 June

The Tenth Summer School on Sensitivity Analysis of Model Output (SAMO) 2018

This Tenth Summer School on Sensitivity Analysis, organised by the Joint Research Centre (JRC), aims at illustrating the motivations to conduct Sensitivity Analysis on simulation models. It offered accessible treatment of the techniques used in Global Sensitivity Analysis. The programme started from the first principles and guided the students through the full range of recommended practices with exercises and application examples.

11-12 June

Scientific and Technical Committee (STC) of EURATOM meeting

The STC gives advice on all nuclear-related matters, based on the Articles 4, 7 and 8 of the Treaty, dealing respectively with research, training and the Joint Research Centre. Its members are appointed by the Council following nomination by the Member States, but its members are named in their personal capacity and thus should not act as national representatives. The meeting took place at the JRC in Karlsruhe.

25 June

Big Data for Migration Alliance- BD4M

The European Commission's Knowledge Centre on Migration and Demography (KCMD) and the IOM's Global Migration Data Analysis Centre (GMDAC) launched the Big Data for Migration Alliance (BD4M) to advance discussions on how to harness the potential of big data sources for the analysis of migration and its relevance for policymaking, while ensuring the ethical use of data and the protection of individuals' privacy. As conveners of BD4M, the KCMD and IOM's GMDAC welcomed the participation of representatives from international organisations and non-governmental organisations, members of national statistical offices, private sector representatives, researchers and data scientists interested in contributing, in various capacities, to realising the potential of big data to complement traditional data sources on migration.
